

SYMPOSIUM REGULATIONS

Why Exhibit?—Provoking Questions about Exhibiting (Extended) Photography

§ 1 General Resolutions

- 1. The organiser of the "Why Exhibit?—Provoking Questions about Exhibiting (Extended) Photography" symposium (hereafter: the Symposium) is the Foundation for Visual Arts, based at ul. Ślusarska 9, 30-710 Krakow (hereafter: the Organiser).
- 2. A participant in the Symposium (hereafter: the Participant) is a natural person who 1) has registered for the Symposium by submitting a form by 25 May 2018, 11:59 pm to: symposium@photomonth.com, 2) has made the payment indicated in § 3 within three days following the submission, but not later than 25 May 2018, and 3) has been accepted for the Symposium by the Organiser. Space is limited at the Symposium, and participation is first come, first serve.

§ 2 The Symposium

- 1. The Symposium will take place on 1 June 2018 in a branch of the Museum of the History of Photography in Krakow, whose headquarters is at ul. Królowej Jadwigi 220.
- 2. The Symposium website is www.photomonth.com/sympozjum. Changes in the Symposium programme will be published on the Symposium website.
- 3. The Symposium is to be held in English.
- 4. Lectures and themed panel discussions will be held during the Symposium.
- 5. Should the Symposium be cancelled, the Participant's fees will be returned in
- 6. The Symposium will be filmed and photographed by the Organiser.
- 7. The Participant holds sole responsibility for any damage caused on the grounds of the site where the Symposium is to be held. The Organiser holds no responsibility for Participants' items that are lost, destroyed, or stolen during the Symposium.



§ 3 Payment

- 1. Payment for participating in the Symposium is 97 PLN for applications submitted and paid for by 10 May 2018 and 147 PLN for applications submitted and paid for by 11 May 2018.
- 2. Within the fee, the Organiser will provide the Participant with three coffee breaks and a lunch.
- 3. The payment does not include travel or accommodation.

§ 4 Closing Resolutions

- 1. In applying for the Symposium, the Participant testifies that:
 - he/she agrees to have his/her personal data in the application form processed by the organisers and their associates for the purposes of organising, promoting, and documenting the Symposium,
 - 2) he/she agrees to allow the organisers and their associates to spread his/her likeness, captured during or in connection with the Symposium, including its dissemination for the purposes of organising, promoting, and documenting the Symposium.
- 2. The Organiser will provide information on changes to the regulations through the Symposium website.
- 3. In matters not covered by these regulations, Polish law applies.
- 4. All conflicts arising from participation in the Symposium will be resolved by the Krakow-City Centre courts.
